All Artisans & Exhibitors must provide a certificate of insurance with no less than \$2 million liability per occurrence. The - "City of Pitt Meadows" must be added as additionally insured on your policy, and the address of the event is 12027 Harris Rd., Pitt Meadows, BC, V3Y 2B5

Your Certificate of Liability Insurance needs to contain a clause providing that it *may not be cancelled, lapsed or materially altered without at least 30 days' notice in writing to The City of Pitt Meadows Day by registered mail.*
