

**CITY OF PITT MEADOWS  
FILMING FEE  
BYLAW NO. 2700, 2016**

A Bylaw of the City of Pitt Meadows to establish Filming Fees

---

**WHEREAS**, the Council of the City of Pitt Meadows is authorized to enact a bylaw pursuant to Section 194 of the Community Charter; AND

**NOW THEREFORE**, the Council of the City of Pitt Meadows in open meeting assembled, ENACTS AS FOLLOWS:

**PART I – INTERPRETATION**

**Citation/Title**

1. This Bylaw may be cited as the City of Pitt Meadows Filming Fee Bylaw No. 2700, 2016.

**Definitions**

2. In this bylaw:
  - a) "City" means City of Pitt Meadows
  - b) "Director" means a City hired Director or a person authorized to act on the Director's behalf

**Fees**

3. The fees for Filming Applications shall be as shown on Schedule "A" attached to and forming part of this Bylaw.
4. No person may use or affect the use of real or personal property, facilities, or equipment owned, held by or in possession of the City, including but not limited to lands, roads, highways, lanes, sidewalks, boulevards, buildings and vehicles for the purpose of film production without first obtaining a permit, except for current affairs and newscasts, on streets or property under the jurisdiction of the City and are authorized by the Director.
5. A non-refundable application fee is required prior to application processing (see Schedule "A").
6. A person using property or services of the City of Pitt Meadows for the purpose of filming production will pay the fees established in Schedule "A" attached to and forming part of this Bylaw.

7. Notwithstanding any fee contained in this Bylaw or the schedule attached thereto, Filming Fees for local non-profit agencies under special circumstances may be reduced or waived at the discretion of the Director.

### **Offence and Penalty**

8. Every person who contravenes a provision of this bylaw is guilty of an offence and is liable on summary conviction to a fine of not less than five hundred (500) dollars and not more than the maximum fine provided by the Offence Act.

### **Effective Date**

9. This Bylaw shall come into force and effect from the date of adoption.

### **Severability**

10. If any portion of this bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion must be severed and the remainder of the bylaw is deemed invalid.

i.	Film Permit Fee (Includes non-refundable administration fee of \$150)	\$ 350
ii.	Student Film Application (no location fee)	\$ 75
iii.	Basic Security Deposit	\$2,000 (minimum)
iv.	Security Deposit with Support (minimum)	\$5,000
v.	City Staff Representative	Hourly wage
vi.	City Staff Representative outside of regular hours	2x hourly wage
vii.	Pre and Post Inspection by City Staff (\$75 per visit)	\$150
viii.	City Park or Sports Field Rental	Daily commercial rate or \$1,500 – whichever is greater
ix.	City Facility Rental	Daily commercial rate or \$2,000 - whichever is greater
x.	Parking	\$ 2.50 per stall
xi.	Failure to obtain a Film Permit	\$ 500
