## **BYLAW NO. 2777, 2017**

A Bylaw of the City of Pitt Meadows to provide permissive exemption from taxation for certain properties

**WHEREAS**, the Council of the City of Pitt Meadows is authorized to enact a bylaw pursuant to Section 224 of the Community Charter S.B.C. 2003, Council may by bylaw, exempt from taxation certain land, improvements or both for Taxation Year 2018 through Taxation Year 2022;
