Note:

- The Coordinating Professional and the Owner of the property must have their signatures on the Building Permit Application Form prior to the application being made
- For projects with multiple buildings, separate application packages with permit drawings are required for each building
- Civil, Landscape and ESC drawings are to be for the entire site
- For townhouse projects only, the drawings are required to be submitted as one complete set for the entire development with separate permit application packages and schedules for each building

NOTE: All submitted drawings are not to exceed a maximum 24" x 36" sheet size
