Pitt Meadows Emergency Services Emergency Dispatch Information

The City of Pitt Meadows Fire & Rescue Service requires that all public buildings or businesses, in the City, provide dispatch information for our emergency response records. We request that you complete this form, even if you have completed one previously, and return it to the Fire Department by one of the following methods:

After Hours Contact:

After hours and/or when the building/business is closed, the Fire & Rescue Service requires contact information for three people, at least one of whom is available **24 hours a day** by telephone to attend within 30 minutes of notification by the Fire & Rescue Service to enter and secure the premises at an incident.

This individual must have all keys and be able to assume full responsibility for the premises.

Fire Protection & Life Safety Bylaw No. 2405 PART SEVEN: FIRE ALARM SYSTEMS

7.1 Contact Persons

- 7.1.1 Every **owner** and **occupier** of any **premises** with a **fire alarm system** must maintain and provide to the **Fire & Rescue Service**, in writing, the names and telephone numbers of three (3) contact persons, at least one of whom is available 24 hours a day by telephone to attend within 30 minutes of notification by the **Fire & Rescue Service** to enter and secure the **premises** at an **incident.**
- 7.1.2 The **owner** or **occupier** must notify the **Fire & Rescue Service** in writing within 7 days of any changes in the names or addresses of contact persons.
- 7.1.3 The owner or occupier must provide to every contact person designated under Section 7.1.1 full access to the **premises** for which they have responsibility and full authority to take control of and operate the alarm system and secure the **premises** on completion of **assistance response** or other **incident**.

We strongly suggest you review the Fire Protection & Life Safety Bylaw No. 2405, Section 7 in its entirety. There are cost recovery fees that will be applicable if a contact person fails to attend an incident. This Bylaw can be found on the City's website at www.pittmeadows.ca
