### Late Tax Payment Deadline is September 30

It is your last chance to pay property taxes and avoid late payment penalties as well as claim your Provincial Home Owner Grant. The City extended the late tax payment deadline due to COVID-19. A 10% penalty will be charged on outstanding taxes as of October 1, 2020.

Ways to pay:

- In-person at City Hall – Customer Service will be open starting September 14.
- Through your bank online or in-person.
- Canada Post – cheques can be mailed.
- City Hall Drop Box – located at the west side main entrance door to City Hall.
